Teathcote in Collingwood Township is the eastern Laterminal on what remains of the old post road. The 8- kilometre long road crosses Euphrasia Township in a north westerly direction and has its western terminus at Griersville in St. Vincent Township.

EUPHRASIA

Thomas A. Stayner, the Postmaster General of the

Province of Canada, wrote to The Honourable D. Daly on

July 26, 1847 as follows,

"Sir: I have the honour to report for the information of the Governor General that I have received authority . . . for establishing post offices at the following places and I have accordingly respectively to request from His Excellency nominations to the respective Postmasterships. The new offices to be opened are . . . Euphrasia, District of Simcoe

- The Postmaster must reside on the main post road between Barrie and St. Vincent (Meaford), about 12 miles from the latter place."1

The need for a post office and the fact that William Rorke had considerable experience as a postmaster led to the Euphrasia post office being established on April 6, 1848 with Mr. Rorke as Postmaster. Euphrasia was the first settlement of any importance in the Township of Collingwood. It may seem unusual to name a post office in Collingwood Township after a neighbouring township, Euphrasia. The Municipal By-law N° 75 of October 9, 1849 reads as follows.

"In respect to the attachment of certain townships to each other. . . . The united townships of St. Vincent, Euphrasia and Collingwood . . . "

On August 31, 1850 Municipal by-law N° 8 was passed and reads in part,

"In respect to the attachment of certain townships – the united townships of Euphrasia and Collingwood in which the senior township shall be Euphrasia."

Part of the village was in Collingwood Township and part in Euphrasia Township. Under the

was natural that since the post office served the two townships it should be named Euphrasia after the senior township.

William Rorke came to Canada in 1822 from Waterford, Ireland. He settled in Hallowell, Prince Edward County where he became the centre of many business activities. Besides being the Crown Land Agent, he was also a merchant, a storekeeper and a postmaster. (Hallowell changed its name to Pictou in 1837.) Two-of Mr. Rorke's sons, Thomas J. and George, journeyed by team and wagon from Hallowell (Pictou) to Euphrasia (Heathcote) area in 1847. They settled on Lot 24, Concession 12, Collingwood Township. They were soon joined by their father, William. A log house was quickly built on this lot. The Euphrasia post office operated from Mr. Rorke's log house. In 1850 Mr. Rorke became a Township Councillor. He took the position of Township Clerk the following year, (1851), and resigned as postmaster. Thomas J. Rorke, his son, who was the treasurer of the United Townships of Euphrasia and Collingwood since 1850 was appointed postmaster in 1851. Thomas Rorke also acted as librarian and clerk of the 4th Division Court which sat at Euphrasia.



The settlement that gradually grew around the post office in the 1850s expanded rapidly into a village known as Williamstown. It was named in honour of an early settler, William Fleming, the father of Sir Sanford Fleming.

Thomas J. Rorke was now a banker, a money lender, a notary public, a general agent for leases, mortgages, a storekeeper and the postmaster. In 1853 the post office moved a short distance south from the log house to Mr. Rorke's new plank house on Lot 23, Concession 12.






Other post offices were being opened in the area so the village fathers in 1859 decided to ask the Post Office Department to rename the post office Williamstown in order to conform to the village name. Since a Williamstown post office already existed in Glengarry County the Post Office Department asked that a new name be chosen. The Rorke family suggested the name Heathcote², which was very descriptive of the location of their house, "a cottage in the flat or scrub". The post

Lasting until the 1980s, the Miller store which had been built about 1853, served as Heathcote's third post office under Geo. Cruikshank Sr. Still standing it has now been coberted to a residence.

office changed its name to Heathcote on October 1, 1861. However the village retained the name Williamstown and did not adopt the new name until about 1874. Thomas Rorke continued as postmaster until June, 1900 when he passed away. He had served as postmaster nearly fifty years.

George Cruikshank Sr. was appointed the new postmaster on July 1, 1900 and on that day moved the post office to his shop which was located north side of Main Street, Lot 3 on the 1944 Heathcote Survey. Mr. Cruikshank was well known having opened a carriage shop in Heathcote in 1869. He also operated a casket factory and was Secretary of the School Board, Union School Section No, 4. When Mr. Cruikshank died on April 30, 1903 his son George Cruikshank Jr. took over the post office and operated it for 11 years until his death on February 9, 1914. In this time period the post office moved to the house just west of the Cruikshank shop (Lot 2 on the 1944 survey).

Mrs. Hannah Cruikshank, wife of George H. Cruikshank was appointed to the postmaster's position on May 18, 1915, a post she held for seven years until 1922 when she resigned.

In this time period there is some confusion between who is postmaster and who were postal clerks. Minnie Hetherington was the clerk that handed out the mail.

The Cruikshank house next to the old Miller store, is said to have been home to the post office (#4) possibly after 1915 when Mrs. Hannah Cruikshank became postmaster following her husband's death.





Still standing in the year 2001 is the home of Robert Murray and the location on the Euphrasia side of Heathcote's fifth post office.

Florence Cruikshank took over after her father died while Minnie continued to help Florence. At the same time William Harris operated the store. All this took place while officially Mrs. Hannah Cruikshank was postmaster. She resigned from the position in 1922.

Her successor was Robert Murray, postmaster from October 22, 1922 until November 12, 1923. Mr. Murray's assistant, Mrs. Isabel C. Fields carried on the post office business. She was officially appointed postmistress on January 2, 1924. In 1928 she resigned.

Robert Murray lived in the house on the west side of the townline and the north shore of the Beaver River. This house is located on a ¼-acre parcel of land on the SE corner of Lot 24, Conc. 1 in Euphrasia Township and with his appointment the post office moved to his house in 1922. It in effect became the fifth location for the Heathcote post office. In the mid-1920s Robert Murray bought the Dr. J. F. McKee's house (Lot 12 on the 1944 Survey) when the doctor moved his practice to Thornbury. Once again the post office moved. This became the sixth location.

Charles H. South purchased the store on Lot 15 (see



1944 survey) in 1925. This store had been built in 1869 by William Hewish. When Mrs. Fields resigned the postmastership in 1928 Charles Smith applied for the position and received the appointment on May 16, 1928. He immediately moved the post office to his store. Sworn in as assistants were Catharine South and Viola Armstrong. In 1932 Viola Armstrong, Katherine L. Armstrong, George C. South and Mrs. H. L South were shown as assistants. In 1938 ownership of the store was transferred to George C. South, a son of Charles. Charles South remained postmaster. Post Office revenue in 1939-40 was \$387.27. The postmaster's salary amounted to \$325.54 In January 1940 Savings Bank business was established at the Heathcote post office. Revenue in 1945-6 had increased to \$761.00. Due to ill health and being 77 years old Charles H. South tendered his resignation as postmaster on September 29, 1947.

The store was sold to Harry Green who had been postmaster at Avening, Ontario for more than 25 years. Green renamed the store, *Harry Green & Sons*. On October 31, 1947 the post office was transferred to him on a temporary basis. The appointment was made permanent on January 30, 1948. The position had been advertised but only Mr. Green applied. During the 1940s

All of Heathcote's doctors occupied this home at one time or another, the last being Dr. J. F. McKee, who sold the house to Robert Murray, Heathcote's sixth postmaster.

Built in 1867 by William C. Hewish, this photo shows the store in 1909 under the proprietorship of R. Conn & Son. It became the post office from 1928 until 1988 under the stewardship of Charles South, Harry, Vernon and Ted Green. Since 1988 it has been the base for the community mail boxes as seen in the photo below.

post office assistants were Charles Vernon Green (son of Harry), Annie G. Green, Otto E. Baker and M. Baker. During Mr. Green's ownership of the store major renovations were carried out and additions added to the building. Saving Bank business was withdrawn on August 15, 1949. Ten years later the Post Office Department advised Mr. Green that due to his age, (he was 72 on November 19, 1959), they planned to appoint his son Charles Vernon Green as postmaster. As of February 1, 1960, Charles Vernon Green was officially the new postmaster. During this period the Heathcote post office was under the supervision of the Meaford postmaster.

Charles Vernon Green relinguished the reigns of postmastership to his son Edward (Ted) Green in 1985. Ted Green remained postmaster until the close of the office on April 29, 1988.

In its effort to assign numbers to post offices, the Post Office department gave Heathcote the following numbers: 3164 (MOON); 392103 (POCON); and NOH 1NO (POSTAL CODE). The size of the office may be judged by the fact that 1973 revenue amounted to \$1,526.00 and the February 2000 householder count is 56, including 4 businesses and 1 rural route handled by the RR#1 Kimberley rural route contractor.

Although the normal steel hammers have been well documented, the story is different for the rubber handstamps – here there is a great possibility to discover other devices. The known proofs are shown herewith.


The story does not end here. Heathcote as a postal address with its postal code of N0H 1N0 continues to this day. Service is now provided by the RR#1 Clarksburg rural route contractor by means of community mail boxes as seen in the photo above.

POST OFFICE BUILDINGS ON POST CARDS

The nearest house on this real photo card has a sign **■** reading HAWKESTONE / POST OFFICE between its two upper windows. This post office was opened under the name Hawkstone on June 1, 1856 with Charles

Young Bell as postmaster, the name being corrected to Hawkestone some time in the 1870s. It was located in Oro Township, Simcoe County, near Lake Simcoe. The card is postmarked with the HAWKESTONE / ONT. duplex (Lee type B-11) on July 12, 1922, during the 1909 to 1944 postmastership of Mrs. Thomas A. Stone, the tenth Hawkestone postmaster; the large sign over the porch in fact reads T. A. STONE / GENERAL MERCHANT.

Bruce Graham lists three different postmarks for this office in his book; one is a HAWKSTONE / U.C double

broken circle, and the others are single broken circles read-

HAWKESTONE / ONT. In addition to the duplex mentioned above, a Lee type S-7 was proofed on May 29, 1953. A мото handstamp was proofed on July 31, 1936.


The post office was housed in the establishment of T. A. Stone, general merchant. This B-11 duplex hammer was proofed September 6, 1913.

A second S-7 duplex hammer was proofed much later on May 29, 1953.





PRESENT-DAY HAWKESTONE

Although one might assume that Hawkestone has passed on into the books of history, it is still very much alive. The old post office (332461) was closed April 1, 1988 at which time the HAWKESTONE/ORO RPO was established.

This in turn was replaced by a retail Outlet (100765) on March 3, 1993.

As early as November, 1996 this outlet was replaced by 10076 one on

Conc. 11, south of the Ridge Rd. with the RC# 259578. Today Hawkestone is served by the Oro Post Office which is the base for three Hawkestone Rural Routes numbering 1070 householders.



to the public on April 30. It was an occasion with all the pomp and ceremony that such a significant event requires. The Town of The Blue Mountain's official town crier was present to call all citizens to take notice and in spite of the threatening weather a good turnout brought a festive atmosphere to the new postal facility.

Following the ribbon cutting ceremony the public was invited inside to the view the new expanded facility and to chat with the various dignitaries of the day. But to put the icing on the cake, refreshments were served including a wonderful cake that was decorated with the Canada Post logo. It was truly a masterpiece – if only the

very once in a while some very interesting or unique aspect about a cover maybe unintentionally overlooked by one collector and noted by another. This is the case in the example of a cover from the collection of Mr. J. C. Campbell.

Mr. Campbell's specific interest in this cover pertained to the study and use of the North Simcoe Branch Railway datestamp and the

road however by road and rail the distance was about 29 miles. Interesting cover!


One important other fact that came to the forefront after I scrutinised the addressee's name is that this cover is addressed to *J Craig* who was the former postmaster of the Craighurst post office. He resigned April 6, 1872. His successor, according to the PORC was Thomas Craig, appointed April 6, 1872 and resigned November 25, 1886. The post office was formerly located in the townships of Flos, Medonte and Oro. The Craighurst post office was permanently closed March 31, 1970.

The cover prepays the correct 5 cent domestic registered rate tied by an unclear handstamp. A nice free



Penetanguishene, Ontario a distance of 34 miles. Ten years later it was absorbed by the Grand Trunk Railway".

These examples are catalogued as RR-113 and are dated DE 12 87. RF is 315. Presently reported span of use is 1881 to 1891. Being a REGISTERED cover it likely contained cash. Anten Mills to Craighurst is about 8 miles by
